Step 3: Click "Choose File," which will then show a dialog box where you can choose a document from your computer. Once you have selected the correct file, click "Open."





Step 4: When you've selected your file, it will be listed next to the Choose Files button; confirm you have chosen the correct file, and then click Validate to run the validation checks on your XML file.

Step 4

Schema Validation Tool

The purpose of the schema validation tool is to help you test the XML files you develop for data submission. This tool will validate your XML files against the published schema only. It will not do more extensive validation (i.e., ensuring you are authorized to submit for the DCE ID in the file). No data is saved by this tool on the server.

Please click Choose Files to locate the XML file on your computer then click the Validate button.

Step 5: Based on the contents of your XML file, the system will provide a report that shows that the file passed all checks, or provides an error report. The report will specify which data element(s) need to be fixed to correct your XML file.

Note: You can run your XML files through the validation tool as many times as you like.

Note: Please be aware that no files are saved at this point. You must submit your interim data and final data files using the Data Submission Tool on the website.

An example error report is shown in the screenshot below; we've added highlights to draw the eye.
